## **ARCHIVAL POLICY ON DISCLOSURES HOSTED ON WEBSITE OF THE COMPANY**

### **• PREFACE**

In pursuance of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”), BFL Asset Finvest Limited (“the Company”) is required to disclose on its website all such events or information which has been disclosed to stock exchanges where the securities of the Company are listed (“Stock Exchanges”) under Regulation 30 of Listing Regulations.
